HFN FUEL CARD, COMMERCIAL:

- A. Parties to this Contract. The Parties to this Credit Sale Contract ("Contract") are Hawaii Petroleum, LLC ("HP") whose principal place of business is located at 385 Hukilike Street Kahului Maui, HI 96732, also doing business as Hawaii Fueling Network ("HFN"), and the below signed commercial Applicant who acknowledges that the fuel and lubricants to be purchased from HP are primarily for business, commercial or agricultural purposes.
- B. **Definitions.** As used in this Contract the term "you," "your" and "Buyer" refers to the Applicant who signs this Contract below or any users authorized by you. Guarantors are persons who signed this Contract who agreed to make your payments for you if you fail to make those payments when they are due.

Upon approval of this application by HP, you agree that the use of the HFN Fuel Card, or any other card device issued by HP ("HFN Card") and/or an HP Commercial Bulk Account (Account) shall be subject to the following terms and conditions:

- 1. **Responsibility.** You agree to pay for all transactions completed by you or by any authorized or unauthorized person using your HFN Card(s). You specifically agree that you will be responsible for all charges on the HFN Card(s) including charges by those persons who may have stolen the HFN Card(s) as allowed by law.
- 2. **Billings.** HP will furnish you with a detailed periodic statement of your purchases at least once a month. You agreed to pay upon receipt of the statement those amounts invoiced to you by HP no later than thirty (30) days following the date of the statement. HP reserves the right to require payment earlier than 30 days upon giving you 10 days advance written notice of the change in payment terms. - 6. NSF (Non-sufficient funds) Fee. You will be assessed a \$35.00 handling fee on all returned checks/share drafts.
- 7. Attorney's fees and costs of collection. If any sums due to HP are not paid in accordance with the terms and conditions set forth above, and the account is turned over to an attorney or collection agency or if suit is brought thereon, you and the Guarantors promise and agree to pay all costs and fees incurred by HP including, but not

If the purchases by Applicant are primarily for a business, commercial or agricultural purpose or the Applicant is a corporation, Limited Liability Company, limited partnership, general partnership, or a limited liability partnership Hawaii's Credit Sales law will not apply to this Contract.

RELOADABLE HFN FUEL CARD:

The Reloadable HFN Fuel Card ("Reloadable HFN Card") is a service of Hawaii Petroleum, LLC ("HP"), and the Reloadable HFN Card can only be used for the purchase of motor fuels at fueling stations that display the "HFN" fueling logo. You can add funds to the Reloadable HFN Card. Call HP at (808) 935-6641 on Hawaii or (808) 270-2802 on Maui during regular business hours for the location nearest you. If there is no activity on your Reloadable HFN Card by either purchasing fuel or adding funds within any 12 consecutive month period, HP will charge a non-use fee of \$15.00 at the end of each 12 month period following the last activity date. If you have questions or want to know the balance of the Reloadable HFN Card, call HP at (808) 935-6641 on Hawaii or (808) 270-2802 on Maui. Reloadable HFN Cards are not redeemable for cash, and can only be used for the purchase of Motor Fuels.

You agree to keep your Reloadable HFN Fuel Card personal identification number ("PIN") separate from the Reloadable HFN Card so that if the Reloadable HFN Card is lost or stolen, the PIN will not be available to an unauthorized user. Treat your Reloadable HFN Card as if it were cash. In the event that a Reloadable HFN Card is lost or stolen, notify HP immediately during regular business hours at (808) 935-6641 on Hawaii or (808) 270-2802 on Maui. In order to cancel the Reloadable HFN Card so it cannot be used by unauthorized users you must actually talk to a person at HP and confirm that the Reloadable HFN Card has been canceled. Leaving a message will not result in the cancellation of the Reloadable HFN Card. In order to cancel a Reloadable HFN Card, you will need to know the name under which the Reloadable HFN Card was issued, the Reloadable HFN Card number, and the PIN. HP will not reimburse you for unauthorized charges on the Reloadable HFN Card.

You will receive a printed receipt at the dispenser after each uses of the Reloadable HFN Card, which will include the remaining balance available on your Reloadable HFN Card. Please keep this receipt for your records. If you believe that there is an error regarding the funds added to your Reloadable HFN Card or the outstanding balance on your Reloadable HFN Card, contact HP during regular business hours to resolve any discrepancies.
